

Posit Service Terms of Use

Posit Software, PBC

These Terms of Use govern your access to and use of Posit ShinyApps.io, Posit Cloud, Posit Connect Cloud at <https://connect.posit.cloud>, the Posit Connect publishing service hosted on <https://bookdown.org/connect/>, the Posit Package Manager service found at <https://packagemanager.posit.co>, Quarto Pub at <https://quartopub.com/>, and the Posit Team Evaluation service found at your personalized URL ending in eval.rstudio.com (collectively the “**Posit Service**”). These Terms of Use limit Posit’s liability and obligations to you, impose certain obligations on you, allow Posit to suspend or terminate your access to and use of the Posit Service, and provide you with other important information with respect to the provision and use of the Posit Service. The Posit Service enables users to upload and share applications and create analyses that have been built using Posit’s proprietary software programs, and, with respect to Posit Package Manager, discover, access, download and use third party packages for the R programming language.

You agree that by signing up to use the Posit Service and registering as a user or by using the Posit Service (in each case, you are a “**User**”), you are entering into a legally binding agreement with Posit Software, PBC in Boston, Massachusetts, USA (“**we**,” “**us**,” “**our**,” and “Posit”) (formerly known as RStudio, PBC). IF YOU RESPOND BY CLICKING ON THE “LOG IN”, “SIGN UP”, “I AGREE”, “I ACCEPT” OR SIMILAR BUTTON TO WHICH THIS AGREEMENT IS LINKED, REFERENCED OR OTHERWISE ATTACHED, YOU ACKNOWLEDGE AND AGREE THAT (i) IF YOU ARE USING THE POSIT SERVICE ON BEHALF OF A COMPANY OR OTHER LEGAL ENTITY (“**COMPANY**”), YOU REPRESENT THAT YOU HAVE THE AUTHORITY TO BIND SUCH ENTITY TO THESE TERMS AND CONDITIONS AND (II) YOU HAVE READ AND UNDERSTAND THESE TERMS OF USE AND ARE AGREEING THAT YOU AND COMPANY WILL BE BOUND BY THESE TERMS OF USE. IF YOU ARE NOT AUTHORIZED TO BIND THE COMPANY TO THIS AGREEMENT OR DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NOT CLICK ON THE “LOG IN”, “SIGN UP”, “I AGREE”, “I ACCEPT” OR SIMILAR BUTTON, DO NOT CONCLUDE THE SIGN UP OR REGISTRATION PROCESS, AND DO NOT USE THE POSIT SERVICE.

Posit may update these Terms of Use from time to time, to, among other things, reflect changes to the Posit Service. We will notify you of changes to these Terms of Use by posting an updated version at <https://posit.co/about/posit-service-terms-of-use> and will revise the “Last Updated” date above. We encourage you to periodically review these Terms of Use to be informed with respect to your and Posit’s rights and obligations with respect to the Posit Service. Using the Posit Service after a notice of changes has been sent to you or published on the Posit Service shall constitute consent to the changed terms and practices.

By agreeing to these Terms of Use, you are also agreeing to our website terms of use located at <https://posit.co/about/website-terms-and-conditions-of-use/>, our Acceptable Use Policy located

at <https://posit.co/about/acceptable-use-policy/> and our Privacy Policy located at <https://posit.co/about/privacy-policy/>. Please review these additional terms and conditions carefully.

Right to Use the Posit Service. On the condition that you comply with all your obligations under this Agreement, we grant you a limited, revocable, nonexclusive, nonassignable, nonsublicenseable right to access, through a generally available web browser or mobile device or application (but not through scraping, spidering, crawling or other technology or software used to access data without the express written consent of Posit) and use the Posit Service for your internal business purposes only (and not to provide services to any third party) in accordance with these Terms of Use, the Acceptable Use Policy and any usage limitations applicable to the Posit Service plan to which You have subscribed. Any other use of the Posit Service is strictly prohibited and a violation of the Terms of Use. We reserve all rights not expressly granted in this Agreement.

You understand that we use third-party vendors and hosting partners to provide the necessary hardware, software, networking, storage, and related technology required to run the Service. You understand that the technical processing and transmission of the Posit Service, including Your Applications, your analyses and any data or information you provide or store in the Posit Service or any application made available via the Posit Service, may be transferred unencrypted and involve (a) transmissions over various networks; and (b) changes to conform and adapt to technical requirements of connecting networks or devices.

Availability of the Posit Service; Eligibility to Use the Posit Service. You have the right to access and use the Posit Service as it exists on any given day and Posit has no other obligation with respect to updating, improving, maintaining, or making available the Posit Service. Further, Posit reserves the right, any time and from time to time, to update, modify, revise, replace, refuse access to, suspend or discontinue the Posit Service, temporarily or permanently, partially or entirely, with or without notice. All of these changes shall be effective upon their posting on our website or by direct communication to you unless otherwise noted. Posit shall not be liable to you or to any third-party for any update, modification, revision, replacement, price change, suspension, refusal of access or discontinuance of the Posit Service or any of Your Applications, analyses, data or information.

To be eligible to use the Posit Service, you must meet the following criteria and represent and warrant that you: (1) are 13 years of age or older; (2) are a human - accounts registered by “bots” or other automated methods are not permitted unless authorized or enabled by Posit; (3) are not currently restricted from the Posit Service; (4) are not a competitor of Posit or are not using the Services for reasons that are in competition with Posit; (5) have full power and authority to enter into this Agreement and doing so will not violate any other agreement to which you are a party; (6) will not violate any rights of Posit, including intellectual property rights such as copyright or trademark rights; (7) will comply with the Terms of Use and Acceptable Use Policy, as each may be amended from time to time, as well as comply with Posit’s website terms

of use referenced above; and (8) agree to provide at your cost all equipment, software, and internet access necessary to use the Posit Service.

Sign Up and Registration. To use the Posit Service, you must complete the sign up process and register as a User. You agree to: (a) provide true, accurate, current and complete information about yourself as prompted by the sign up process and registration form (“User Data”) and (b) maintain and promptly update the User Data to keep it accurate and current. If you provide any information that is inaccurate or not current, or Posit has reasonable grounds to suspect that such information is inaccurate or not current, Posit has the right to suspend or terminate your account and refuse any and all current or future use of the Posit Service. Your login may only be used by one person - a single login shared by multiple people is not permitted. You may create separate logins for as many people as your plan allows.

Account Security. You are responsible for safeguarding the password that you use to access the Posit Service. You agree to: (1) keep your account password secure and confidential; and (2) not permit others to use your account. Further, you are responsible for any activities or actions under your account or anything that happens through your account, whether or not you have authorized such activities or actions, until you disable your account or prove that your account security was compromised due to no fault of your own. You will immediately notify Posit of any unauthorized use of your account. You acknowledge that if you wish to protect your transmission of data and/or files to Posit, it is your responsibility to use a secure encrypted connection to communicate with and/or utilize the Posit Service.

“Your Application(s)” as used in this Agreement means a computer program independently developed by you (or on your behalf) and/or deployed by you using the Posit Service, including computer programs which you permit other Posit Service Users or the general public to access and use in accordance with the license terms applicable to Your Application. You agree to make any license terms applicable to Your Application available to Users of Your Application by linking or otherwise prominently displaying such terms to Users when they first access or use Your Application.

By using the Posit Service, you represent and warrant that (i) you are in compliance with these Terms of Use, (ii) you own or otherwise have all rights and permissions necessary to submit to Posit and the Posit Service Your Applications and any analyses, data, or other information that you submit to the Posit Service and to share and license the right to access and use Your Application to Users, as applicable, and (iii) Your Application and any analyses, data, or other information that you submit to the Posit Service does not violate, misappropriate or infringe the intellectual property rights of any third party and is not in violation of any contractual restrictions or other third party rights. If you have any doubts about whether you have the legal right to submit, share or license Your Applications and any analyses, data, or other information, you should not submit Your Applications or any analyses, data, or other information that you submit to the Posit Service. You may remove Your Application from the Posit Service at any time or if the Posit Service does not include a feature that permits you to remove Your Application, you

may request that Posit remove Your Application at any time by contacting Posit support at support@posit.co.

Posit does not claim ownership of Your Application; however, you hereby grant Posit a worldwide, perpetual, irrevocable, royalty-free, fully paid up, transferable and non-exclusive license, as applicable, to (i) access, use, copy, adapt, publicly perform and publicly display Your Application and any analyses, data, or other information that you submit to the Posit Service in connection with providing the Posit Service to you and your Users and (ii) with your permission, to internally access, copy and use Your Application to review the underlying source code of Your Application for purposes of assisting you with de-bugging your Application. You acknowledge and agree that the rights granted in (i) may be exercised by Posit's third party hosting provider in connection with their provision of hosting services to make the Posit Service available to you and your Users.

If you choose to, you can share Your Applications, and any analyses, data, or other information that you submit to the Posit Service, with the general public, or with specific individuals or Users you select to the extent the Posit Service supports such functionality. If you decide to share Your Application, and/or any analyses, data, or other information that you submit to the Posit Service, you are giving certain legal rights, as explained below, to those individuals who you have given access. Posit has no responsibility to enforce or police, or aid you in enforcing or policing, the terms of the license(s) or permission(s) you have chosen to offer. POSIT IS NOT RESPONSIBLE FOR MISUSE OR MISAPPROPRIATION OF YOUR APPLICATIONS AND /OR ANY ANALYSES, DATA, OR OTHER INFORMATION THAT YOU SUBMIT TO THE POSIT SERVICE BY THIRD PARTIES.

Posit reserves the right to remove and/or disable any of Your Applications and any analyses, data, or other information that you submit to the Posit Service, with or without notice, if deemed by Posit to be contrary to the Terms of Use or Acceptable Use Policy. For avoidance of doubt, Posit has no obligation to store, maintain or provide you a copy of any of Your Applications and any analyses, data, or other information submitted to the Posit Service and any of Your Applications and any analyses, data, or other information that you submit are at your own risk of loss.

Your Use of Applications Made Available Via the Posit Service. If you access or use any of the applications which are submitted or otherwise made available by other Users or by Posit through the Posit Service, including without limitation any R, Python or similar packages made accessible or available through Posit Package Manager, you acknowledge and agree that your use of such applications is subject to any license terms, terms of use or other permissions granted by the licensor of the application and you agree to comply with such terms. You further acknowledge and agree that Posit does not have any obligation to monitor applications uploaded by Users and disclaims all responsibility and liability for your use of applications made available to you through the Posit Service, including without limitation the accuracy, completeness, appropriateness, legality, security, availability, or applicability of the applications

and you hereby waive any and all legal or equitable rights or remedies you have or may have against Posit with respect to the applications that you may download, share, access or use.

If you choose to upload data to an application you are using via the Posit Service, you acknowledge and agree you are giving certain legal rights to the licensor of the application to process and otherwise use your data. Please carefully review any license terms accompanying any application to which you submit your data for the legal rights which you are giving the application licensor. Further, Posit does not claim ownership of your data; however, you hereby grant Posit a worldwide, perpetual, irrevocable, royalty-free, fully paid up, transferable and non-exclusive license, as applicable, to (and to permit its third party hosting provider to) use and copy your data in connection with making your data available to the application (and the licensor of such application) to which you have submitted your data. You acknowledge and agree that even if you remove your data from the Posit Service, your data may have been downloaded by, and remain accessible to, the licensors of those applications to which you submitted your data. Accordingly, do not submit data which you desire to remain confidential or which you wish to limit the right to access or use. You should never submit to the Posit Service any data which consists of personally identifiable information, credit card information, or protected health information, as such terms are defined by relevant laws, rules, and regulations. POSIT IS NOT RESPONSIBLE FOR THE CONFIDENTIALITY, AVAILABILITY, SECURITY, LOSS, MISUSE OR MISAPPROPRIATION OF ANY DATA YOU SUBMIT TO THE POSIT SERVICE OR ANY APPLICATION MADE AVAILABLE VIA THE POSIT SERVICE.

Types of Accounts; Price Changes; Payments; Refunds; Upgrading or Downgrading Your Plan. Posit allows you to use the Posit Service, without charge, as is set forth under the free plan entitlements applicable to the Posit Service (the “Free Plan”). You acknowledge and agree that with respect to the Free Plan, Posit’s branding will appear with Your Applications or analyses. One person may not maintain more than one free account for each Posit Service.

Posit also offers paid plans under which you would be entitled to additional features and capabilities, subject to your payment of the applicable fees to Posit when you place your order for a paid plan as set forth at <https://posit.cloud/plans/> or <https://www.shinyapps.io/> (a “**Paid Plan**”). The Posit branding will not appear in Your Applications or analyses under a Paid Plan and Paid Plans may have additional features and functionality which are not available to you under the Free Plan as described in the plan entitlements applicable to your plan.

All fees for Paid Plans are exclusive of all Taxes. “Taxes” means any sales, use, GST, value-added, withholding, or similar taxes, customs, and any customs duties, charges, fees or levies, whether domestic or foreign, excluding taxes based on the income, employees or property of Posit. You are responsible for payment of all Taxes unless you provide Posit with a tax exemption certificate. If you are required by applicable law to withhold any Taxes from your payment, the fees payable by you will be increased as necessary so that after making any required withholdings, Posit receives and retains (free from any liability for payment of Taxes) an amount equal to the amount it would have received had no such withholdings been made.

If Posit is required to collect and remit Taxes pursuant to applicable laws, Posit will include the Taxes payable by you on your invoice or on your receipt for your online order, as applicable. The amount of the Taxes will be calculated based on applicable laws. You acknowledge that the taxation of online transactions is continually evolving and that Posit continues to monitor and update its taxation policies as those laws change. You agree to pay any Taxes that Posit is required to collect and remit pursuant to applicable laws.

ALL PAID PLAN PURCHASES ARE FINAL AND NO REFUND WILL BE GIVEN FOR UNUSED PORTIONS OF YOUR INITIAL OR ANY RENEWAL PAID PLAN SUBSCRIPTION PERIOD.

If you upgrade from the Free Plan to any Paid Plan, we will immediately bill you using the credit card you have provided.

For monthly payment plans, the Posit Service is billed in advance on a monthly basis and is non-refundable. For annual payment plans, the Posit Service is billed in advance on an annual basis and is non-refundable. UNLESS OTHERWISE PROVIDED IN YOUR ORDER WITH POSIT, ALL PAID PLANS WILL AUTOMATICALLY RENEW FOR SUCCESSIVE MONTHLY OR ANNUAL PERIODS, AS APPLICABLE, UNLESS YOU CANCEL YOUR ACCOUNT PRIOR TO THE RENEWAL DATE.

The Posit Service will prorate subscription changes. If a subscription is upgraded or downgraded during a period, the prorated additional charges will be invoiced and charged immediately. Any prorated credits will be applied to future invoices. For subscription changes between different intervals, the billing cycle will be reset when the subscription is changed. Note that if we charge for the new plan, and that payment fails, the plan change will not go into effect.

Prices of all Paid Plans are subject to change upon 30 days notice from us; provided, however, that, if you are currently a Paid Plan subscriber, we will honor your existing Paid Plan price for the greater of the remainder of your subscription period or 90 days from the date of our notice. Such notice may be provided at any time by posting the changes to the Posit website for the Posit Service or as otherwise provided under the Notifications and Service Messages section below.

You are solely responsible for properly cancelling your account. You may cancel or downgrade your Paid Plan account by visiting your “**Account**” page and selecting “**Downgrade**” or “**Cancel**”. Cancellation of a Paid Plan will downgrade your account to the Free Plan. The cancellation or downgrade of a Paid Plan will go into effect immediately. There will be no refunds or credits for partial months of service, upgrade/downgrade refunds, cancellation refunds, or refunds for months unused with an open account. In order to treat everyone equally, no exceptions will be made. Cancellation of your Free Plan will result in the deletion of all information and data from your account and such information and data cannot be recovered after cancellation of your Free Plan.

Posit, in its sole discretion, has the right to suspend or terminate your account and refuse any and all current or future use of the Posit Service, or any other Posit Service, for any reason at any time. Such termination of the Posit Service will result in the deactivation or deletion of your account or your access to your account, and the deletion of all information and data in your account. Posit reserves the right to refuse service to anyone for any reason at any time.

Notifications and Service Messages. For purposes of service messages and notices about the Posit Service to you, you agree that Posit may notify you via the email address associated with your account, even if we have other contact information. You also agree that Posit may communicate with you through your Posit account or through other means including email, mobile number, telephone, or delivery services including the US Postal Service. You acknowledge and agree that we shall have no liability associated with or arising from your failure to maintain accurate contact or other information, including, but not limited to, your failure to receive critical information about the Posit Service.

Restrictions on Use. You must comply with all applicable laws, rules, regulations and guidelines, and you further agree not to do any of the following:

- Post, publish or transmit any data, information, files, text, graphics, or other material that: (i) is false or misleading; (ii) is defamatory; (iii) invades another's privacy; (iv) is obscene, pornographic, or offensive; (v) promotes bigotry, racism, hatred or harm against any individual or group; (vi) infringes, violates or misappropriates another's rights, including any intellectual property rights; or (vii) violates, or encourages any conduct that would violate, any applicable law, rule or regulation (including those with respect to privacy and/or data security) or would give rise to civil liability;
- Upload, input or transmit any Sensitive Data, where "Sensitive Data" means (a) social security numbers, passport numbers or other government issued id numbers; (b) health or medical information, including without limitation Personal Health Information as defined by HIPAA; (c) financial account information or payment card data, including any information subject to the Gramm-Leach-Bliley Act or PCI-DSS; (d) information that must be protected in accordance with specific or heightened security requirements imposed by applicable laws, rules or regulations or industry standards or which would require notification to government agencies, individuals or law enforcement if subject to unauthorized access, use or disclosure; (e) information that reveals gender, racial or ethnic origin, political opinions, religious or philosophical beliefs, trade-union membership, sex orientation or activities, or genetic or biometric data; or (f) other information which a reasonable person would recognize as being highly sensitive;

- Use a Posit Service or an Application to store or transmit security vulnerabilities, viruses or other harmful or malicious code;
- Interfere with or disrupt the integrity or performance of any Posit Service;
- Attempt to gain unauthorized access to any Posit Service or its related systems or networks;
- Permit direct or indirect access to or use of any Posit Service in a way that circumvents a contractual usage limit, or use any Posit Service to access, copy or use any of Posit's intellectual property;
- Modify, copy, or create derivative works of a Posit Service or any part, feature, function or user interface thereof;

below) into subsequent versions. The Posit Service is protected by copyright, trademark, and other laws of both the United States and foreign countries. Except as expressly permitted in these Terms of Use, you may not reproduce, modify or prepare derivative works based upon, distribute, sell, transfer, publicly display, publicly perform, transmit, or otherwise use the Posit Service.

All feedback, comments, and suggestions for improvements that you provide to Posit, in any form, and the results, metrics, analysis and statistics resulting from access to and use of the Posit Service and applications and content made available via the Posit Service (collectively, the “**Feedback**”) will be the sole and exclusive property of Posit. You hereby irrevocably transfer and assign to Posit all of your right, title, and interest in and to all of your Feedback, including all worldwide patent rights (including patent applications and disclosures), copyright rights, trade secret rights, and other intellectual property rights (collectively, the “**Intellectual Property Rights**”) therein. The foregoing intellectual property rights provisions shall survive any termination or expiration of these Terms of Use.

Digital Millennium Copyright Act Compliance. You will only upload, post, submit or otherwise transmit data and/or files: (i) that you have the lawful right to use, copy, distribute, transmit, or display; or (ii) that does not infringe the intellectual property rights or violate the privacy rights of any third party (including, without limitation, copyright, trademark, patent, trade secret, or other intellectual property right, or moral right or right of publicity). Posit has adopted and implemented a policy that permits the deletion of files that violate this policy, and will terminate the accounts of Users who repeatedly infringe or are believed to be or are charged with repeatedly infringing the rights of copyright holders. Misuse of the Services. If you violate any of these Terms of Use or the Acceptable Use Policy, your permission to use the Posit Service will automatically terminate and Posit may disable your account. Posit reserves the right to revoke your access to and use of the Posit Service at any time, with or without cause, and with or without notice.

Your access to and use of the Posit Service is at your own risk.
